


Vision




President's Message




2010 was a year of transition for ICA, the second year of movement toward a new membership subscription formula. This formula has aided the recruitment of new members and we now celebrate a record level of membership. It has come, however, with an overall reduction of revenue for ICA and its regions, which is causing the organisation to make long-needed changes in operational practices.

2010 also marked a transition in staff leadership of ICA, with the retirement of lain Macdonald after eight years as Director-General. During his tenure, lain concentrated on raising the profile of international co-operation, particularly in its potential for resolving some of the world's problems. In recent years he was heavily engaged in the statutory and subscription formula changes the organisation is now implementing. We all owe him a debt of gratitude for his service.



With the announcement in late 2009 that the United Nations had declared 2012 as the International Year of Co-operatives, the Board adjusted priorities to ensure that we fully leverage the opportunity that the UN name brings. We believe that we must achieve one thing in 2012 and do it well: raise public awareness of the co-operative as a values-based business model.



The public awareness campaign begins with a high-level slogan and a logo. ICA worked with the UN to craft a slogan consistent with the message we want to convey during the Year: "Co-operative enterprises build a better world." It was important to ICA that the slogan capture both the social and the economic aspects of our model. The concept of our public awareness campaign is to integrate the slogan and logo into all of our members' marketing and communications materials and products during the International Year.

Complementing this member-based public awareness campaign will be a global media campaign, targeting key media with specific positioning material that communicates the values-based enterprise model of co-operatives. We will be developing that material, and incorporating member stories, during 2011. Additional materials, posters, and videos are envisioned to supplement this core work. The messages and stories will also appear on ICA's 2012 web site: www.2012.coop.

Director-General's message



at this exciting time in its history—at the advent of the International Year of Co-operatives. We are in the preparatory year for the International Year, and it is a critical moment.

When I look at co-operatives around the globe, I see a movement with solutions to serious challenges that confront the world today. And I believe we have a responsibility to tell our story. Co-operatives are at the centre of global business, but we have to tell our story not just because of our size and scale, but also because of our relevance, our importance especially at this time in history, and because of the solutions we bring.

We have a responsibility to tell our story, because if we don't, governments will unwisely emphasize the corporate structure in their economic development strategies. Today, the international community is searching for solutions to the global recession. We have a solution.

We have a responsibility to tell our story, because if we don't, workers, craftsmen, and farmers will languish due either to the recession and stagnation affecting much of the world today or due to the rapid economic growth in other countries that always leads to the economic displacement of some. They will languish unaware that co-operatives offer them a way to improve their lives.

We have a responsibility to tell our story, because if we don't, someone else will define the co-operative brand, because we will have left a vacuum for this to happen. Banks will talk about the danger of credit unions; business competitors will disparage consumer owned co-operatives; and well-meaning developers

will share old, tired stories of the limits of the co-operative model in economic development.


If we use the International Year properly to tell our story, we will lay the foundation for continuing visibility; we will strengthen our relationships with key media channels; we will position co-operatives as an important media source for future business stories; and we will improve our capacity to distribute consistent messages through the channels within our movement.

Capturing the opportunity the Year presents and relaunching the global co-operative brand will require that ICA has strong communications and policy skills. We are modifying our structure to ensure that we have these skill sets and that we are providing substantial member value.

I look forward to working with you to ensure that the co-operative becomes widely recognized as the solution it is to today's global challenges.

Principles



he co-operative principles are guidelines by which co-operatives put their values into practice.

1. Voluntary and Open Membership

Co-operatives are voluntary organisations, open to all persons able to use their services and willing to accept the responsibilities of membership, without gender, social, racial, political or religious discrimination.

2. Democratic Member Control

Co-operatives are democratic organisations controlled by their members, who actively participate in setting their policies and making decisions. Men and women serving as elected representatives are accountable to the membership. In primary co-operatives members have equal voting rights (one member, one vote) and co-operatives at other levels are also organised in a democratic manner.

3. Member Economic Participation

Members contribute equitably to, and democratically control, the capital of their co-operative. At least part of that capital is usually the common property of the co-operative. Members usually receive limited compensation, if any, on capital subscribed as a condition of membership. Members allocate surpluses for any or all of the following purposes: developing their co-operative, possibly by setting up reserves, part of which at least would be indivisible; benefiting members in proportion to their transactions with the co-operative; and supporting other activities approved by the membership.

4. Autonomy and Independence

Co-operatives are autonomous, self-help organisations controlled by their members. If they enter into agreements with other organisations, including governments, or raise capital from external sources, they do so on terms that ensure democratic control by their members and maintain their co-operative autonomy.

5. Education, Training and Information

Co-operatives provide education and training for their members, elected representatives, managers, and employees so they can contribute effectively to the development of their co-operatives. They inform the general public - particularly young people and opinion leaders - about the nature and benefits of co-operation.


6. Co-operation among Co-operatives

Co-operatives serve their members most effectively and strengthen the co-operative movement by working together through local, national, regional and international structures.

7. Concern for Community

Co-operatives work for the sustainable development of their communities through policies approved by their members.

aving an International Year of Co-operatives (IYC) provides an opportunity to captivate the attention of national governments, the business community and, most importantly, the general public on the advantages provided by the co-operative model.

By specifying a theme for an international year, the UN draws attention to issues of global significance and this theme was chosen for 2012 in part because co-operation is clearly part of what the UN is all about. The UN's goals for the IYC are to:

- Increase public awareness about co-operatives and their contributions
 to socio-economic development and the achievement of the Millennium
 Development Goals.
- 2. Promote the formation and growth of co-operatives.
- 3. Encourage governments to establish policies, laws and regulations conducive to the formation, growth and stability of co-operatives.

As the global voice of co-operatives, ICA has chosen to focus on increasing public awareness during the IYC as the most efficient and effective way to use our resources. In 2010 we began to plan for the approaching international year with the expectation that executing those plans would take place in 2011.

Operational report

ollowing the restructuring of ICA's membership categories and subscription formula, we immediately began to experience an anticipated benefit from the changes: an increase in new members. 2010 ended with 14 more, bringing the total to 245 from 92 countries. But restructuring did not come without pain and the loss of some members. While past practice has been to reserve half of the proceeds from each General Assembly for the following year, all of the 2009 proceeds were used that year. As a result, 2010 brought a significant financial deficit.

lain Macdonald retired as Director-General in 2010 and his replacement, Charles Gould, took over on 1 September. At the Board's direction, Mr. Gould presented a plan to restructure the global office in December, which the Board approved for implementation in 2011. It will realign global staffing with the organisation's strategic priorities and its new revenue model. A major feature is identifying the Director-General and the four Regional Directors as the senior global management team. Global support staff will be recruited in strategic geographic locations.


Africa

The new fees structure makes annual subscriptions more affordable, which is helpful for members. One new member joined the organization.

We took the first steps to create the Endowment Fund for the long term sustainability of the regional office, showing that the solutions to regional challenges can be found in the region itself.

We continued to meet with Co-operative Development agencies and special mention goes to the Swedish Co-operative Centre and the Canadian Co-operative Association for their support with the ICA Africa's Strategy Plan. New Agreements with the two partners were signed, while the ILO COOPAfrica project, in which the office actively participated, ended on 31 December 2010. We also began to collaborate with NISPED in Israel so that managers and cooperative leaders will enjoy training opportunities in that institution.

Finally, the office moved to better premises and secured more professional staff and we are grateful to the Co-operative Insurance Company of Kenya for seconding staff.

Americas

Although membership declined slightly from 78 to 71 members during 2010, our team of 10 people celebrated two decades of work in the region and opened a new building with facilities that cater much better to the needs of the organization. We also enjoyed a strong financial performance throughout the year, with solid cash flow that points to how fully the co-operative movement in the region supports the work of ACI-Americas and the ICA in general.



With the help of the Swedish Co-operative Centre, our project on Advocacy, Governance and Co-operative Development continued to help co-operatives strengthen their advocacy capacity and improve their governance. As part of this project we held several academic activities and conferences to raise awareness about advocacy and governance, ethics and leadership issues, including events in Nicaragua and Colombia, as well as initiatives focusing on youth and gender topics.





We continue to put the 2009-2012 Strategic Plan into effect, with significant advances in different areas, including some changes in how we allocate and integrate responsibilities within the team to create greater efficiency.

Asia-Pacific

In 2010, celebrating 50 years of service to the Asia-Pacific region, we focused on greater interaction with members, bringing new countries into the ICA and evolving innovative strategies for developing a new generation of co-operatives, as well as continuing our capacity-building programs for co-operative development.

Six new organisations from Iran, China, India, Japan and the Philippines joined ICA in 2010, bringing us to 71 members from 25 countries in the region. Meanwhile, we participated in three important events to continue building influence – two in China and one in Saudi Arabia – and in March held an exploratory mission to Thailand and the Philippines.

We were also involved in various training programmes in the sectors of agriculture, consumers and business and participated in several meetings pertaining to governance, including the ninth meeting of our regional assembly, where new rules were approved.


Europe


out a study on implementing the Regulation on the European Cooperative Statute (SCE), which led to some guidelines for reviewing the regulation. The conclusions, which were presented during a seminar in October 2010, will be part of the revision procedure of the regulation by the Commission.

Cooperatives Europe is a vital partner for the EU in increasing the impact of its development policy, in particular with regard to the role of the private sector and we focused on several areas during 2010:

- Partnership: Cooperatives Europe participated in the Civil Society
 Organisation (CSO) Group on International Development, an informal network to exchange knowledge and address EU development policies.
- Relations with EU institutions: we actively participate in the Structured
 Dialogue together with Member States, EU Parliament, EU Commission and
 other CSOs for developing a future EU development strategy.
- Pilot project: in 2010 we finished preparing the co-operative development project in Montenegro, to be implemented in 2011/2012.

Responding to trends in EU policy, Cooperatives Europe set up an energy working group that began drafting a regional strategy for the co-operative movement in the energy sector and designed a five-step action plan covering an 18-month period. The long term goal is a truly competitive energy market that is open to new energy producers and that integrates small scale energy production installations. Co-operatives will work with EU officials to shift the perception that citizens are mere energy users to one where they play an active and responsible role as energy consumers and/or producers.


