

SUSTAINABLE DEVELOPMENT The International Co-operative Alliance illustrated the daily contributions of cooperatives to United Nations ambassadors during the International Day of Cooperatives 2017 and became the first global economic player to formally commit to achieving the 17 SDGs (Sustainable Development Goals), showing that cooperatives act together to: - Reduce poverty - Ensure food safety and sustainability - Produce clean energy - Help refugees and provide essential services to communities - Create sustainable jobs - Support gender equality The partnership signed between the International Co-operative Alliance and the European Commission is a concrete example of combining forces to address our responsibilities on the world stage, particularly in relation to Sustainable Development. Thanks to this partnership we have strengthened our concerted actions in all ICA regions.



In 2017, the President, Monique F. LEROUX, worked with the Board of Directors on an in-depth review of the actions and activities of the International Co-operative Alliance, addressing a number of topics including a review of the financial situation, communication, involvement of primary cooperatives and membership in order to ensure that the actions and priorities of the International Co-operative Alliance remain in line with global issues.

This work was the subject of an action plan that was presented to the regional and sectorial bodies and elicited a series of comments from them.

LEADERSHIP & ECONOMY



The cooperative voice was heard by several international (United Nations) and regional (European Union) institutions and during various forums such as the B20 in Germany.

The International Co-operative Alliance proposed courses of action on employability, small and medium-sized enterprises, health, education, digital economy, sustainable development and trade and promoted the co-operative model among international political and economic leaders.

Global conference:

"Cooperatives: putting people at the centre of development"

The conference saw some 1,500 people participate, including 500 from Malaysia and 300 staff members and volunteers from ANGKASA (Malaysian National Co-operative Movement). The global conference met the criteria for geographic distribution, gender equality and balance of young people.






MEMBERS PER REGION IN %
