Territory can become an economic asset, a place for cooperation and synergy, and a product of differentiation as well. By having structures from different fields cooperating in a transversal way, a territory can develop innovative and coherent supply for goods and services, giving it a real economic advantage. It can also allow it to come up with new responses to social and environmental complex issues. An endogenous and efficient local development has to go through this transversal approach.

Examples: Agritourism, ecotourism

- Workshop 2: Developing a European cooperative exchange network Thinking about the interest of setting a platform up to encourage exchanges between cooperatives at a European level. In order to support the cooperatives working on the commercialization of ethic, local and organic goods, is there any better way than getting the products required in other cooperatives? Support a European fair trade! Examples: Online solidarity stores, directory of producers, transports' pooling, carbon compensation, transports' effectiveness.
- <u>Workshop 3</u>: Growing sectors: which position to adopt on green economy for cooperatives?

The ecological and economic crisis urges us to adopt new behaviors encouraging the creation of new services and activities. How can the cooperative sector co-operate to gain access to new markets? Which entrepreneurship consistent with sustainable development to propose?

Examples: renewable energies, eco-friendly building, waste management, recycling.

12.00-1.30pm: Workshop on European funds

The aim is to improve knowledge about European programmes and funds related to the cooperative economy and more generally speaking to cooperation between companies.

The programs introduced here will be related to the thematic working groups in order to help cooperatives to develop concrete transnational projects.
